

OFFICIAL RULES

Promotion Description:

The deugro group raffle (the "Raffle") is administered by dservice GmbH. The Raffle will grant one lucky winner a new iPad (64 GB; connectivity: Wi-Fi; colour not defined). Between the first 1000 subscribers who sign up to the deugro group Market Report via the deugro group website, a winner will be randomly selected in a random drawing. This Raffle does not include administrative costs, shipping, or taxes however they may apply.

Eligibility:

In order to be eligible you must be at least 18 years old. Public Officials are not eligible. For purposes of this Raffle a "Public Official" is any official or employee of any government or government-controlled entity, any political party or official thereof, or any candidate for political office. To enter the Raffle, you need to subscribe as one 1000 subscribers to the deugro group Market Report via the deugro group website and confirm the subscription.

Official Prize:

The prize for this raffle is a new iPad (64 GB; connectivity: Wi-Fi; colour not defined) valued at EUR 369,40. This Raffle does not include administrative costs, shipping, or taxes however they may apply.

Winner Selection:

The Raffle will end once 1000 people have subscribed to the deugro group Market Report and the winner will be announced soon after the Raffle end date. The winner will be chosen in a random drawing and will be notified by email. Verification of the Raffle potential winners are subject to verification by dservice GmbH, whose decisions are final and binding in all matters related to the Raffle. Potential winners must continue to comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. The potential winner will be notified by email. Each potential prize winner will be required to sign and return an Affidavit of Eligibility, Liability and Publicity Release (the "Affidavit") (except where prohibited), which must be received by dservice GmbH within thirty (30) days of the date of notice or attempted notice is sent, in order to claim their prize. If a potential winner of the prize cannot be contacted, fails to sign and return the Affidavit within the required time period (if applicable), or prize is returned as undeliverable, such potential winner forfeits the prize. In the event the prize winner is disqualified for any reason, dservice GmbH will award the prize to an alternate winner by random drawing among all remaining eligible entries.

Release:

By receipt of any prize, winner agrees to release and hold harmless dservice and their respective subsidiary, and affiliate companies, as well as each such company's officers, directors, employees, and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Raffle or receipt, use, or misuse of any prize.

Privacy:

Except where prohibited, participation in the Raffle constitutes winner's consent to the deugro group data Privacy Policy and Mail Chimp's Privacy Policy and Terms linked to the deugro group website.

General Conditions:

dservice GmbH reserves the right to cancel, suspend and/or modify the Raffle, or any part of it, if any fraud, or other factor beyond dservice GmbH's reasonable control impairs the integrity or proper functioning of the Raffle, as

determined by dservice GmbH in its sole discretion. In such event, dservice GmbH reserves the right to award the prize at random from among eligible entries received up to the time of the impairment. dservice GmbH reserves the right, in its sole discretion to disqualify any individual, without compensation, it finds to be tampering with the entry process or the operation of the Raffle or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Raffle may be a violation of criminal and civil law, and, should such an attempt be made, dservice GmbH reserves the right to seek damages from any such person to the fullest extent permitted by law. dservice GmbH's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Limitation of Liability:

The Released Parties are not liable for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors, or by any of the equipment or programming associated with or utilized in the Raffle; (2) unauthorized human intervention in any part of the entry process of the Raffle; (3) technical or human error which may occur in the administration of the Raffle or the processing of entries; or (4) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Raffle or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Raffle.

Disputes:

Except where prohibited, entrant agrees that: (1) any and all disputes, claims, and causes of action arising out of or connected with this Raffle or any prize awarded shall be resolved with the individual in their own personal capacity; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Raffle if any, but in no event attorney's fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant claims all rights to claim, indirect, punitive, incidental, and consequential damages and any other damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and dservice GmbH in connection with the Raffle, shall be governed in accordance with the laws of Switzerland. Any controversy arising under or in relation to this Agreement shall be settled by arbitration. The arbitration shall have its seat and be held in Zurich, Switzerland in the English language and shall be arbitrated under the rules of the International Chamber of Commerce ("ICC") by an arbitrator appointed by the ICC. The decision of such arbitration shall be final and binding upon the parties, and the cost of the arbitration, including the fees and expenses of the arbitrator(s), will be shared equally by the parties, with each party paying its own attorney's fees. As a formality and not for the purpose of judging the validity thereof, the arbitration decision and award may be submitted to a court with jurisdiction in the place where any party hereto may be found for the purpose of recognition and enforcement of the arbitration decision and award.
